- 4. Freshman Letter to Parents: Email completed.
- 5. Request for Purchase from Boys Tennis: The Request for Purchase Form needs to be completed to formally request payment for the tennis banner. Debbie Hodges motioned to spend \$774. Michelle Schaefer seconded. All in favor. Motion carried.
- 6. Request for Purchase from Girls Basketball: \$1,905 to pay half the cost of new girls basketball home and away uniforms approved at the last meeting.
- 7. Concession Stand Locks: The outdoor concession stand door locks have been repaired. Brian will ask Gabe to get a quote for a fob system or similar.
- 8. Facebook Page Administration: Rosemary Martin and Brian O'Leary are managing the page. Brian would like to continue with two administrators.

NEW BUSINESS:

- 1. Sub-committee for Facilities Improvements:
 - 501c3: Paul Nyffeler can assist with obtaining 501c3 status. The initial cost is \$500 and the annual cost is \$400 to file taxes. Brian O'Leary will discuss with the school

business manager to ensure the school does not object.

- 5. Middle School Cheer Event: This event will be held January 13. Brian will find out more details.
- 6. Concessions Payments: Julie Kader would like the club to consider using a card reader. Brian O'Leary is meeting with the business manager about a card reader for game admission.
- 7. Sponsor Statuses and Brochure: On September 8, by way of Executive Committee, Debbie Hodges motioned to spend \$1,250 to print the sports programs. Laura Cesar seconded. All in favor. Motion carried. The sports programs will arrive tomorrow. Laura Cesar will send the certificates and thank you letters to the sponsors.
