DISBURSEMENTS: Reid Oldenburg presented a Request to Purchase by Dave Lindow for (10) EZ Travel Cart Bags at \$23.99 each plus shipping from Sports Warehouse. These will be used by both boys and girls tennis and will be stored in the tennis garage. Ted Zess motioned to approve the purchase of 10 cart bags at \$23.99 each plus shipping. Debbie seconded. All in favor. Motion carried.

OLD BUSINESS:

- 7. Drum & Bugle Corp competition: Saturday August 3rd. Reid will talk to the Music Boosters to see if they want to work the concession stand.

1. By-Law changes for next year need to be made at the Annual Meeting on May 6th: We are going to remove the Concessions Coordinator as an Officer position, but retain the position.
