SECETARY'S REPORT: Casey Heimos motioned to approve the report. Marolyn Komperud seconded. All in favor. Motion carried.

TREASURER'S REPORT: Concessions income consisted of \$1012.32 from boys basketball, \$1115.80 from girls basketball, \$1177.75 from wrestling. Administrative expenses consisted of \$107.89 for annual SignUpGenius and \$29.95 for checks. Seven \$500 scholarships from 2019 were paid out. Kiwanis was paid \$400 for 4 football games, \$6000 was paid for the basketball shooting guns and there was a \$100 donation to STEAM. Debbie Hodges motioned to approve the report. Brenda Raddeman seconded. All in favor. Motion carried.

DISBURSEMENTS: Reid said that Yearbook is asking if we would like to place our annual advertisement. Debbie made a motion to spend \$300 on a full page ad. Marolyn seconded. All in favor. Motion carried.

OLD BUSINESS:

- 1. Kiwanis Club was paid for their participation in 4 football games last fall.
- 2. A new TV for above the concession stand was donated by the Raddeman family.
- 3. Reid will get a list of the spring sports parents from Mary Harding so we can get them loaded into SignUpGenius.

NEW BUSINESS:

- 1. By-Law changes: We discussed adding the Concession Chairperson back onto the By-Laws as an Officer position. We discussed again giving sports chair people some incentives such as sports passes and swag.
- 2. If we are going to make the Concession Chair position a paid position we need to create a Job Description. We will work on creating Job Descriptions for all of the Officer positions including the Membership Chair position.
- 3. We will need chair people for Softball, Soccer and Baseball.
- 4. A new fan is needed in the indoor concession stand.
- 5. There was another offer of a donation of a microwave. We do not have an immediate need for it but we will take it and put it in storage to be used when needed.

6. Scholarships for 2020: Debbie motioned to set aside \$5000 for scholarships for 2020 seniors with the number of scholarships given and the dollar amounts to be determined at a later date. Pam Donegan seconded. All in favor. Motion carried.

Casey motioned to adjourn. Brian Chapman seconded.
