The East Troy Community School District Board met in regular session on June 22, 2015. The meeting was called to order by President, Ted Zess at 7:00 p.m. followed by the Pledge of Allegiance. Ted Zess read the open meeting statement indicating that the meeting is open to the public as required by state statute and that notice of the meeting had been sent to the media and/or posted.

A motion was made by Dawn Buchholtz and seconded by Martha Bresler for approval of the agenda and amended agenda as posted. Motion carried unanimously.

Stat. 19.85(1)(c). Roll call: Steve Lambrechts, yes; Martha Bresler, yes; Dawn Buchholtz, yes; Ted Zess, yes. Motion carried unanimously. Meeting adjourned at 8:54 p.m.

XIV. RECONVENE TO OPEN SESSION

A motion was made by Dawn Buchholtz and seconded by Ted Zess to reconvene to open session. Roll call: Steve Lambrechts, yes; Martha Bresler, yes; Dawn Buchholtz, yes; Ted Zess, yes. Motion carried unanimously. Meeting reconvened to open session at 9:57 p.m. A motion was made by Dawn Buchholtz and seconded by Ted Zess to approve administration's recommendation for restoring certain 15-16 reductions pending State return of the -\$150 per pupil reduction to include restoring a CPI 1.62% increase to admin and supervisors to be the same as teacher and support staff rather than the salary freeze, health contributions back to 9% from 10% for all employees, a half-time AD secretary, and a custodial staff compensation preventative maintenance increase. Motion carried unanimously.

A motion was made by Dawn Buchholtz and seconded by Steve Lambrechts to approve the administration's recommendation for two supplemental pay proposals. Motion carried unanimously.

A motion was made by Dawn Buchholtz and seconded by Steve Lambrechts to approve the Fund 80 youth choir director position and program. Motion carried unanimously.

XV. ADJOURNMENT

A motion was made by Ted Zess and seconded by Dawn Buchholtz to adjourn. Motion carried unanimously. Meeting adjourned at 9:59 p.m.
