NEW MEMBERS: Tony and Peggy Turner renewed their annual membership

SECRETARY'S REPORT: Debbie Hodges motioned to approve the January report. Rosemary Martin seconded. All in favor. Motion carried.

TREASURER'S REPORT: Income for January consisted of \$12,580 from concessions and \$100 from a Hall of Fame donation. Expenses for January consisted of \$3,982 for concessions, \$900 for administration, \$2,000 for scholarships, and \$6,000 for the scoreboard. Michelle Schaefer will earmark \$6,000 for the 10th scoreboard payment on the upcoming Treasurer's Report. Shawn Golabowski motioned to approve the January report. Debbie Hodges seconded. All in favor. Motion carried.

DISBURSEMENTS:

1. Debbie Hodges requested \$200 for the Hall of Fame event deposit at Alpine Valley. Shawn motioned to approve. Laura Cesar seconded. All in favor. Motion carried.
2. Brian O'Leary requested \$5,760 for track warmups, \$1,308 for varsity softball jackets, and \$2,500 for football helmets. The warmups and jackets will need to be ordered within the next 2 weeks to be here in time for spring sports. Debbie Hodges made a motion to approve the track warmups, softball jackets and football helmets if the pending donation from another party towards the scoreboard occurs. Shawn Golabowski seconded. All in favor. Motion carried.
3. Shawn Golabowski requested two payments of \$90 to reimburse Sariah Pluess and himself for ice cream purchased from Culver's.

OLD BUSINESS:

1. Venmo Account Update: Michelle Schaefer stated that the account is ready to be used.
2. Winter Concessions: The cheer event was very large and concessions were very busy.
3. Golf Outing Committee Update: Planning is going well. They are working on advertising and will soon be asking for volunteers for the event.
4. Football Scoreboard Update: Brian O'Leary shared that a new donor has indicated that they would like to contribute to the scoreboard purchase.
5. 2025 Scholarships: The committee is waiting to receive the applications.
6. Vice President & Treasurer Seats: These positions are open for the 2025-26 school year.
7. Concession Coordinator Stipend: The Murphy's need to decide if they would like to receive their payment from the school or the booster club.
8. Marketing Piece for Local Businesses: Morgan Lese shared that the table cards will be in several businesses by the end of this week.

NEW BUSINESS:

1. Stein's Volunteer Opportunity: Doug Beth proposed the same volunteer schedule as last year, with 10 volunteers for 4 hours on Tuesdays, Wednesdays, Thursdays and Saturdays at the Waukesha and Big Bend stores. The sessions would be from April 29 through June 1. We want to thank Doug for this great fundraising opportunity.
2. Post Prom Donation: Debbie Hodges motioned to donate \$50 to post prom. Lindsey Phillips seconded. All in favor. Motion carried.
3. Raffle License B: Michelle Schaefer will check on the status of the B license.
4. Halloween Bash donation thank you note received from the Key Club.
