SECRETARY'S REPORT: Debbie Hodges motioned to approve the December report. Michelle Schaefer seconded. All in favor. Motion carried.

TREASURER'S REPORT: Income for December consisted of \$5,426 from concessions. Expenses for December consisted of \$3,735 for concessions, \$25 to Parent Booster USA for a state tax filing, and \$25 for raffle license type A to sell tickets in advance of an event. Debbie Hodges motioned to approve the December report. Rosemary Martin seconded. All in favor. Motion carried.

DISBURSEMENTS:

- Brian O'Leary would like to hold contests during half time at the basketball games and requested
 concessions items as prizes for the winners. Debbie Hodges motioned to approve up to \$10 per
 home boys and girls basketball games for halftime giveaways, Shawn Golabowski seconded. All in
 favor. Motion carried.
- 2. Shawn Golabowski requested a check to purchase Culver's ice cream for the concession stand.

OLD BUSINESS:

- 1. PayPal/Venmo Account: An Eventbright account has been created for the golf outing; it is free to use. Michelle Schaefer spoke with a Parent Booster USA representative and he recommended Venmo. Shawn Golabowski will be the named individual for the Venmo account.
- 2. Raffle License: Michelle Schaefer reported that the A license for selling tickets in advance has been granted and a B license for when tickets are sold only on the day of the event is still pending.
- 3. Winter Concessions Update: The Murphys reported that the people running concessions are doing a great job.
- 4. Golf Outing Committee Update: Shawn Golabowski shared that the golf outing coordinator at Alpine Valley will manage the event. We will need volunteers for the day but she is going to run it. Fees have been determined and advertising is in draft form.
- 5. Football Scoreboard Update: Brian O'Leary shared that the Gridiron Club has not declared the amount of their contribution to a new scoreboard. Once he has that number, he will be able to make a formal request to the Booster Club.

NEW BUSINESS:

- 1. Switch Popcorn Makers: The indoor concession stand popcorn maker smokes. David Murphy will look into this.

Debbie Hodges will respond to Mary Harding. Scholarships will be presented on May 7. At this time, \$5,000 has been earmarked for scholarships.
- 4. Open Positions: The Vice President and Treasurer positions are open for the 2025-26 school year.
- 5. Stipend for Concession Coordinators: The school district has paid the stipend in the past but now the club is able to pay the stipend. The Murphys will speak with the administration office to get more information.
- 6. Next Meeting: The next meeting will be held on Monday, February 3, 2025 at 7:00 p.m. at East Troy High School in Room 805.
