The East Troy Community School District Board met in regular session on October 27, 2014. The meeting was called to order by President, Ted Zess at 7:00 p.m. followed by the Pledge of Allegiance. Ted Zess read the open meeting statement indicating that the meeting is open to the public as required by state statute and that notice of the meeting had been sent to the media and/or posted.

- B. Acceptance of Donation(s): A motion was made by Martha Bresler and seconded by Dawn Buchholtz to accept the \$200 donation to the school's library from The Women's Club of East Troy. Motion carried unanimously. A motion was made by Dawn Buchholtz and seconded by Martha Bresler to accept a \$20,000 donation to the East Troy School Building Fund from the Vennice A. Segebarth estate. Motion carried unanimously.
- C. <u>Policy 830 Community Use of Facilities:</u> A motion was made by Dawn Buchholtz and seconded by Steve Lambrechts to approve the changes to Policy 830, Community Use of Facilities, as presented. Motion carried unanimously.
- D. <u>Organization request for Board of Education consideration to a special exemption policy 851:</u> A motion was made by Dawn Buchholtz and seconded by Ted Zess to approve an exemption to Policy 851 for the United Way request. Motion carried unanimously.
- E. <u>Choose Board of Canvassers for election in November:</u> A motion was made by Dawn Buchholtz and seconded by Steve Lambrechts to approve the Board of Canvassers to include Martha Bresler, Tim Griffin and the Board Clerk for November 10, 2014 at 4:00 p.m. at the District Office. Motion carried unanimously.
- F. <u>2015 2016 District Calendar Area school districts are currently increasing daily minutes in order to decrease the number of school days required.</u> Mrs. Zwirgzdas shared that one less day would save about \$5,600. Ten fewer days would save approximately \$56,000. The Board has asked administration to develop the 2015 2016 school year calendar while exploring minor changes.
- G. <u>Update regarding School Bell</u> The East Troy Historical Society is interested in adding the school bell to their collection. This topic will be brought back to the next Board meeting for action.
