EAST TROY COMMUNITY SCHOOL DISTRICT BOARD OF EDUCATION

Regular Meeting Minutes – January 17, 2022

The East Troy Community School District Board met in regular session on January 17, 2022. The meeting was called to order by Vice-President Anna Janusz at 6:02 p.m followed by the Pledge of Allegiance. Board members also present were Dale Ames, Bob Dignan, and Steve Lambrechts. Absent was Ted Zess. Steve Lambrechts was unavailable at the start of the meeting, but returned at 6:50 p.m. during item E. Also present were Dr. Christopher Hibner, Amy Foszpanczyk, Kathy Zwirgzdas, administrators/supervisors, and three guests. Anna Janusz read the open meeting statement indicating that the meeting is open to the public as required by state statute and that notice of the meeting had been sent to the media and/or posted.

IV. APPROVAL OF AGENDA AS POSTED

A motion was made by Bob Dignan and seconded by Dale Ames for the approval of the agenda and the amended agendas as posted. Motion carried unanimously.

V. APPROVAL OF MINUTES

A motion was made by Bob Dignan and seconded by Dale Ames to approve the minutes of the December 13, 2021 regular board meeting, with a correction on page 8 to the misspelling of Anna Janusz's name, and the December 13, 2021 special board meetings. Motion carried unanimously.

Adam Witkiewicz spoke about the long length of the school board meetings, which he states is a contributor to non-involvement.

- C. <u>Staffing Recommendation(s)</u>: Bob Dignan made a motion to approve the hire of Madison Gruman for ES music. Dale Ames seconded the motion. Motion carried unanimously.

Approval of donation(s): Bob Dignan made a motion to approve the donation(s) with thanks from the district: Ogden Construction for \$200 for Battle Bags, an anonymous donation for \$6,500 for Battle Bags, WE Energies \$300 matching Jessica Fuch's donation, A.A.T. Infrared, Inc. for \$500 to the HS wrestling program, Mr. Mike Howard \$400 toward the HS Wrestling program, Ms. Nancy Forjan \$200 toward the HS wrestling program, Chris and Laura Edwards \$225 towards the HS wrestling program, Jeff and Jeaneen McPherson \$225 towards the HS wrestling program, and the First Congregational Church of East Troy \$500 donation. Dale Ames seconded the motion. Motion carried unanimously. We also reported on the recent VOICE grant written by Jinnesa Pluess from Gateway for ECE electronic babies to the High School.
