EAST TROY COMMUNITY SCHOOL DISTRICT BOARD OF EDUCATION Referendum Presentation and Regular Meeting Minutes – January 20, 2020

The East Troy Community School District Board met for a referendum presentation and then regular session on January 20, 2020.
