Regular Meeting Minutes – June 29, 2020

The East Troy Community School District Board met in regular session on June 29, 2020. The meeting was called to order by President Ted Zess at 6:04 p.m followed by the Pledge of Allegiance. - C. <u>Select option to be used for the 2020 Graduation Ceremony:</u> Bob Dignan made a motion to approve the modified graduation of 100% in person as outlined, however if circumstances were to change and this becomes unworkable, to move to 100% virtual. Jessica Fuchs seconded the motion. Motion carried unanimously.
