Regular Meeting Minutes – May 10, 2021

The East Troy Community School District Board met in regular session on May 10, 2021. The meeting was called to order by President Ted Zess at 6:00 p.m followed by the Pledge of Allegiance. Board members also present were Dale Ames, Bob Dignan, Anna Janusz, and Steve Lambrechts. Ted Zess read the open meeting statement indicating that the meeting is open to the public as required by state statute and that notice of the meeting had been sent to the media and/or posted.

Janet spoke on recent changes in the news, including vaccine availability coming for younger children (12-16 today), no longer quarantining if vaccinated, new masking options, 6 ft apart is down to 3 ft but the definition of close contact hasn't changed. Universal face coverings are still be recommending by the organizations we follow (CDC, Walworth County Health Department, etc.). Summer school less volume, utilizing space, ventilation system, outdoor spaces – may have opportunities for utilizing this to help distancing and barriers. Federal law currently indicates public transportation, which includes school buses, requires face masks.
